## <u>Budget</u>

Janel DeZarn, Business Administrator, presented her portion of the District report. Background information was given. Property values increased in some of the municipalities this year within the Columbus School District. Discussion was held and questions were asked by district residents regarding the proposed budget and tax levy. (Copy of presentation on file.)

# Adoption of the tax levy.

The final information from the State will be provided to the District around October 15<sup>th</sup>. The Board will adopt the final budget and set the levy at the October 23<sup>rd</sup> board meeting. Henry St. Maurice moved to adopt the proposed, preliminary tax levy. Seconded by Paul Rubert.
