#### WHAT'S NEW?

- Bray and the District Core Planning Team (CPT) have continued to meet bi-weekly.
- The second User Group Meetings were held on October 7. These are short meetings held with staff members during which the design team gets focused feedback on specific building areas. The user groups will continue to meet with the design team approximately once a month.
- The District had a coordination meeting with engineers on October 12. This allowed the Bray team, the engineers, and the District to continue to work through questions related to site, structural, electrical, plumbing, and mechanical systems.
- Elementary Furniture User Group meetings were held on October 21 to gather feedback from staff on furniture selections.
- The third round of subcommittee meetings were held on October 28 to gather staff feedback on both the elementary and high school projects.

#### WHAT'S NEXT?

- The High School Furniture User Groups will meet in November. In these meetings, the design team will assess furniture options selected by groups of staff members.
- Exterior material selections will be presented to the District for final approval, along with renderings.

#### **PLANNING + DESIGN UPDATE**

- The Bray team presented preliminary interior finishes to the District
- The floor plans continue to be fine-tuned.
   The District has been running mock scheduling exercises to ensure all classes have a home in the new buildings.
- The District's food service consultant, Boelter, has been working closely with the District and Bray to develop equipment layouts for the elementary and high school kitchens.
- The Bray team is locking for opportunities to integrate historical, educational, and interactive graphic design elements that will celebrate the Columbus School District community.

#### **DISTRICT-WIDE UPDATES**

The Bray team, the engineers, and the District met with Focus on Energy to begin selecting an energy-savings bundle. This is a design plan including energy-efficient mechanical, electrical, plumbing, and architectural strategies that will reduce energy usage.

The Bray team and engineering consultants completed a 50% progress set of construction documents (plan drawings) on October 30. This will be used for budgeting and coordination with C.D. Smith Construction.

## Hello famílies,

I hope all of you are doing well! Here are a few reminders for you as we enter into the 3rd month of school...

- 1. Please be as specific and descriptive as possible when leaving a voicemail regarding your student's absence. Information that should be provided in the message includes: the child's full name, grade, teacher, and the reason for their absence. In addition, please indicate whether your child has tested positive for COVID-19, has been in close contact with someone diagnosed with COVID-19, or if they have any of the following symptoms: fever, chills, cough, difficulty breathing/shortness of breath, nasal congestion, runny nose, new loss of taste or smell, sore throat, headache, unusual fatigue, muscle or body aches, nausea, vomiting, and/or diarrhea. Including this information allows us to prioritize and follow-up with the appropriate families in a timely manner.
- 2. Many have expressed confusion on what it means to be a close contact of someone who has been diagnosed with COVID-19. A person is considered a close contact if any of the following criteria have been met, even if facial coverings were worn, or physical barriers were used:
  - a. Within 6 feet of a positive COVID-19 case for 15 minutes or more, within a 24-period.
  - b. Had direct physical contact with a positive COVID-19 case (i.e. hug, kiss, or handshake).
  - c. Had contact with a positive COVID-19 case's respiratory secretions.
  - d. Live with a positive COVID-19 case or stayed overnight for at least one night in a household with them.
- 3. If your child is tested for COVID-19, for any reason, please remember to keep them home while waiting for their test results! If they have been identified as a close contact, and they test negative, they must still remain in quarantine for 14 days after their last exposure to the positive case.
- 4. With the holidays in the near future, it is important to be aware of safe practices regarding travel during COVID-19. A few of these include:
  - a. Wear a mask to keep your nose and mouth covered when using public transportation for travel (i.e. planes, trains, subways, taxis, etc.).
  - b. Stay at least 6 feet away from other passengers that do not live in the same household as you do.
  - c. Wash your hands often! Bring hand sanitizer for those times when running water and soap is not available.
  - d. DO NOT travel if you are sick!
  - e. Consider self-quarantining for 14 days upon return for any travel outside of your local community. Monitor for symptoms during this time and report any concerns to your healthcare provider.
- 5. Columbia County will be offering free COVID-19 testing sites in the upcoming month. Please see the date/times of these opportunities for free testing:
  - a. November 6<sup>th</sup>, 8:30 AM to 4:30 PM @ the Cambria Fire Department
  - b. November 10<sup>th</sup>, 8:30 AM to 4:30 PM @ the Columbus Community Center

- c. November 20<sup>th</sup>, 8:30 AM to 4:30 PM @ the Cambria Fire Department
- d. November 25<sup>th</sup>, 8:30 AM to 4:30 PM @ the city of Portage Utility Building
- e. December 4<sup>th</sup>, 8:30 AM to 4:30 PM @ the Cambria Fire Department

## **Curriculum News**

#### **Virtual Learning Details Plans**

Over the past several weeks, the district has been gathering information about what is working well and what needs to be improved with our instructional plan. One of the things we have heard is that there is a strong preference for an increase in live, synchronous instruction on

virtual days; however, there is also concern about amount of screen time and many other factors. Taking all feedback into account, the district has been working with staff on a revised plan going forward. Beginning the week of November 3rd for K-8 and November 9th for 9-12, the attached virtual learning details plans will apply on ALL VIRTUAL DAYS. Please consider printing and posting your child(ren)'s plan(s) somewhere that is easily accessible.

- K-5 Virtual Learning Details Plan
- 6-8 Virtual Learning Details Plans
- 9-12 Virtual Learning Details Plans
  - o For Virtual Students while school is on Cohort/Blended schedule
  - Optional schedule the school use if CHS transitions to ALL virtual (Only use if directed to by the district.)

Covid-19 is absolutely a concern when it comes to the possibility of all virtual days being a necessity, but as we head into Wisconsin winter, so is the weather. This year, there will be **no snow days**. If weather should dictate that it is unsafe for students and staff to come to school, the day will be treated as an **all virtual day** instead. So for example, if what in the past would have been a snow day occurs on a Monday, we will follow the Monday schedule for live/recorded instruction.

#### **Grades K-5 (Cohort/Blended Students)**

While the district is open for in-person instruction M/Tu/Th/F, your child will receive in-person instruction like normal. On Wednesdays, your child's teacher will post work in the Google Classroom and may also work with you in advance to set up any additional small group video conferences.

If at any time, your child's classroom, grade level, school, or the school district is converted to all virtual instructional for a period of time (whether that be to the pandemic or a "snow" day), the attached <u>K-5 Virtual Learning Details Plan</u> will apply.

#### **Grades K-5 (All Virtual Students)**

Currently, your child has the opportunity to participate in live, synchronous instruction with their teacher every day. If the school or district must close for a short period of time, there will **not** be significant changes to the live, synchronous instruction schedule that their teacher currently uses. If the school or district should have to close for a significant period of time (ex: like when the state closed schools for three months last spring), the district would reassess this plan at that time.

#### Grades 6-8

Grade 6- Currently, cohort/blended students receive in-person instruction on Monday/Tuesday and virtual instruction Wednesday-Friday. On Mondays and Tuesdays, nothing will change for cohort/blended or all virtual students. Since Wednesday-Friday are all virtual days for every Grade 6 cohort, beginning Nov. 3rd, the attached schedule will apply for 6th graders on Wednesday-Friday.

Grades 7 & 8-Currently, cohort/blended students receive virtual instruction Monday-Wednesday and in-person instruction on Thursday/Friday. Since Monday-Wednesday are all virtual days for every Grades 7 & 8 cohort, beginning Nov. 3rd, the attached schedule will apply for 7th and 8th graders on Monday-Wednesday. On Thursdays and Fridays, nothing will change for the cohort/blended or all virtual students.

There is a minimum of 15 minutes built in between each class on all virtual days for "tech breaks." On virtual days, if a student is able, we expect them to show up for their live class. For those who are unable to make it, we will video the instruction and post it in the Google Classroom.

If at any time, a student's cohort, grade level, school, or the school district is converted to all virtual instructional for a period of time (whether that be to the pandemic or a "snow" day), classroom teachers will teach live instruction at the time that the class is scheduled to meet based on the CMS Virtual Learning Details Plan schedule. #### Grades 9-12

CHS is different from the rest of the schools because with all the choices in classes, it is impossible to "cohort" the same group of students for an entire day. So, to mitigate risk, when students are in-person at CHS, instead of attending six classes, in order to lessen the number of people students are exposed to on a given day, students attend three classes each day for two hours at a time on a modified block. Because some high school classes have multiple grade levels that may be present for in-person instruction on different days, the modified block schedule is utilized M/Tu/Th/F, regardless if it is a student's in-person or virtual days. Beginning the **week of November 9th**, the attached (9-12) Virtual Learning Details Plan (Cohort/Blended Schedule) will apply.

If there comes a time this school year when CHS has to transition to ALL virtual instruction for a period of time, for instructional purposes, the school also has an option to transition to the (9-12) ALL Virtual Learning Details Plan (All Virtual Option) schedule. This is just an alternate option we want you to be aware of in case we decide it is in the best interest of students in the future. We will not transition to this schedule for quick closures (ex: snow day) or even if for example, 9th/10th grade are all virtual, but 11th/12th grade is not. Only use this schedule if notified to do so.

Because we don't want students glued to their computers for multiple hours in a row, live instruction may not last the entire class period. Teachers may provide instruction and then want students to practice independently on their own or complete work outside of their computer. On virtual days, students who are able are expected to

show up for their live class. For those who are unable to make it, we will video the instruction and post it in the Google Classroom.

#### **Conclusion**

The Covid-19 pandemic has affected everyone and changed education in many ways. One thing that has not changed is that providing all students with a guaranteed, viable curriculum and education is still Columbus School District's top priority. But, we need your help. Regardless of the learning environment, students have a responsibility to attend school and participate in their education. The district and its staff have the responsibility to provide students with a high, quality education. Neither side can do it alone.

Some school districts require students to attend live, synchronous classes on virtual days. We understand that some of you believe we should be doing that as well. However, we also understand that not all students and family situations will allow this. We do expect that students who are able to attend class live do so, and students who cannot attend a live session make it up by watching the recording and keeping up with the classwork.

Updating our live, synchronous instruction protocol is a significant change, but please know that because of your feedback, other improvements will be happening behind the scenes as well. Thank you for being our partner in education.

#### **National Career Development Month**

Career development begins well before students are in high school deciding their post-secondary course of action. As educators and as caregivers, we all expose students to careers through our discussions about work; through encouraging pursuit of hobbies, skills, clubs, and sports; and through helping students assess their strengths and their preferred ways of learning.

In classroom lessons across all grade levels, school counselors facilitate conversations on the above topics while guiding students through more personalized exploration. One way we're able to do this in middle and high school is through the software program Xello. When using Xello, students learn about how their school subjects can apply to careers, while exploring how their own interests, personality, and strengths best "match" them to specific careers. Using Xello is an incredibly fun way for students to start exploring the many options available to them!

#### **Transgender Awareness Week**

Transgender Awareness Week is a week when transgender people and allies work to make visible the realities of being transgender - the experiences, the stories, the prejudices, and the discrimination. The week ends with Transgender Day of Remembrance, commemorating the lives of transgender people lost to interpersonal violence.

According to the American Academy of Pediatrics, adolescents who identify as transgender are disproportionately more likely to attempt suicide. You can get involved as an ally by reporting defamation, being mindful of a person's privacy if they are discussing identity exploration with you, advocating for inclusivity in your community and workplace, and challenging trans-phobic comments or jokes.

#### **World Kindness Day**

Let this day serve as a reminder to be kind to others, to the world, and to yourself! <u>Inspire Kindness</u> has many resources for getting involved, like graphics for sharing on social media and tips for bringing more kindness into the workplace. 
## **Columbus Middle School**

# Free Meals Extended Through June 2021
